

## VISITATION

While the greater community is opening at a quicker pace and dropping the mask mandates, we are required to follow the regulations from the State Department of Health, CMS, and the CDC. As the vaccination rates increase, it does allow more flexibility for visitation. The risk of variant strains of COVID-19 and the spread of COVID-19 to unvaccinated Residents and Staff still exists.

Volunteers and staff will monitor for compliance with the Core Principles of COVID-19 Infection Prevention during visitation hours.

### **Core Principles of COVID-19 Infection Prevention:**

1. Screening, of all who enter the facility, for signs and symptoms of COVID-19, and denial of entry of those with signs or symptoms or those who have had contact with someone with COVID-19 infection in the prior 14 days. (regardless of the visitor(s) vaccination status)
2. Hand Hygiene
3. Face covering or mask (covering mouth and nose) and social distancing at least six feet between persons *unless* both the Resident and visitor(s) are fully vaccinated, physical touch can then be allowed.
4. Cleaning and disinfecting high frequency touched surfaces in the facility often, and designated visitation areas after each visit.

### **Definitions:**

**Private Setting:** A private setting is either a designated visitation area on the South Unit or a Private Resident room.

**Fully vaccinated:** A person is considered fully vaccinated greater than or equal to 2 weeks following the receipt of the second dose of either the Moderna or the Pfizer COVID-19 vaccine, or greater than or equal to 2 weeks following the receipt of the Johnson and Johnson COVID-19 vaccine.

Compassionate Care Visits	Compassionate Care Situations
<ul style="list-style-type: none"> <li>➤ All Compassionate Care visits MUST be scheduled</li> <li>➤ Visitors must schedule visits with the nurse on the unit where the resident resides at the following extensions:  <b>Transitional Care Unit (TCU) 330-893-3200 ext. 1380</b>  <b>North Unit 330-893-3200 ext. 1340</b></li> <li>➤ Visitor must self-screen at the main entrance and follow signs to the Unit of the Resident</li> <li>➤ Compassionate Care visits are set for 2 hours <b>maximum</b></li> <li>➤ No more than 3 visitors per visit</li> <li>➤ Children under the age of 10 years not permitted unless the visit can take place Outdoors</li> <li>➤ Sticker must be placed in visible area on clothing for staff to identify you</li> <li>➤ Mask must be worn while walking to/from the Resident Room</li> <li>➤ Socializing with peers inside the facility is not permitted, visitors are expected to walk directly to the room of the Resident being visited</li> <li>➤ If the Resident is in quarantine, the visitor MUST wear a mask for the entirety of the visit despite vaccination status</li> <li>➤ Social distancing is required, UNLESS the Resident is fully vaccinated OR both Resident and Visitor are Both fully vaccinated</li> <li>➤ When in quarantine, social distancing is required</li> </ul>	<ol style="list-style-type: none"> <li>1. A resident, who was living with their family before recently being admitted to a nursing home, is struggling with the change in environment and lack of physical family support</li> <li>2. A resident who is grieving after a friend or family member recently passed away</li> <li>3. A resident who needs cueing and encouragement with eating or drinking, previously provided by family and/or caregiver(s), is experiencing weight loss or dehydration</li> <li>4. A resident, who used to talk and interact with others, is experiencing emotional distress, seldom speaking, or crying more frequently (when the resident had rarely cried in the past).</li> </ol>

## VISITATION
